# **Corrections Desk Activity Update**

Warm greetings from the Corrections Desk here at the General Service Office (GSO) US/Canada. It is so nice to be in touch with you all again. My name is Eileen I have the privilege of serving as GSO Staff Coordinator on the Corrections assignment.

If you are a new Corrections chair – welcome aboard! As many of you know, your Area Registrar can update information in our Fellowship Connection database for new committee chairpersons; although some new committee chairs contact us directly to provide their contact information. In any event, please continue to reach out when changes are made so we can continue to have the most up to date information to send you current information from the office.

I am pleased to share the following highlights that I hope you find useful as you carry the message to those inside the walls.

# **Corrections Correspondence Service (CCS)**

The revised sign-up form updated for inclusivity and to help clarify requests will be print ready and available on the website shortly.

We still need Spanish speaking men from the eastern US to correspond with persons in custody, women participants on the inside in the US and all inside and outside participants in Canada.

We also need participants who identify as Transgender and Non-binary.

How you can help: Please share the CCS sign up forms at your home group, at the various correctional settings you visit and any other A.A. event you attend. Sign-up forms and pre-stamped envelopes are available at the GSO free of charge.

## **Corrections Correspondence Service for Canada**

**The Canadian corrections working group** continued to support the efforts to increase awareness and participation of CCS in Canada made by past corrections trusted servants.

We had a successful meeting with the Correctional Services Canada (CSC) which serves the Federal Prison system in Canada. The CSC requested that we help organize a meeting between the corrections trusted servants and the regional professionals to ensure that A.A. is available in all 43 facilities. We provided the sign-up forms and information that we have an international pre-stamped envelope available to defray postage cost. We have had a few persons in custody sign up for this service and hope to have many more.

We were informed that CSC is 3-5 years away from having an infrastructure to support the use of tablets that can provide digital access to A.A. literature.

#### **Prerelease Contact Information**

The A.A. Corrections Prerelease Contact Service connects the A.A. member being released from prison with A.A. in their community.

#### **Digital Literature Behind the Walls**

Conference-approved AAWS and AA Grapevine copyrighted eBooks and audiobooks are available on tablets and desktops in the various correctional settings in the U.S., and can now be accessed by people who are incarcerated and by the professionals who serve them. Thanks to the 7<sup>th</sup> tradition contributions of members, we have contracts with several vendors so we can provide literature at no cost to persons behind the walls.

**What can you do?** Local trusted servants, who work in correctional settings in the U.S., can ask their contacts which vendors they use. Areas are served by different vendors. Each facility can be autonomous and has their own contracts. We have contracts with many major vendors including ViaPath, Edovo/GTL, Securus-Jpay or Ingram

CoreSource – OverDrive so our e-book and audiobook content can be accessed. Additional vendors will be added, and we hope to provide quarterly updates.

Please contact <u>corrections@aa.org</u> to learn if there is tablet use in your area, which literature titles are being accessed most and for any additional information.

## **Corrections Kit (M-45I)**

The Corrections workbook is in its final stage of revision. An updated English version is expected March 2023. A section on sponsorship is included in the Corrections workbook.

The proposed agenda item *Consider a request to include content to existing A.A. literature on sponsorship of persons in custody by outside members of the fellowship* will be discussed by the Corrections Conference Committee.
